## Announcing the 50<sup>th</sup> Annibersary of the TRB Workshop on Transportation Law

he Legal Resources Group of the Transportation Research Board is pleased to announce the **50th Annual Workshop on Transportation Law**. This annual workshop is unique in bringing together lawyers representing federal, state, and local agencies and the private sector who work in all areas of transportation law. The Workshops aim to keep practitioners current on important areas of the law, while reflecting the growth and evolution of America's transportation system.

We have invited high level dignitaries from the United States Department of Transportation and the Honorable Alan Boyd, the first Secretary of the United States Department of Transportation, to join in the celebration of our 50th Workshop. We are also planning a special program to reflect on the continuing importance of one of the most influential transportation cases ever to come before the United States Supreme Court, Citizens to Preserve Overton Park v. Volpe. The program will include Secretary Boyd, John Vardiman who argued the case before the Supreme Court, and Charles Newman, who represented the plaintiffs throughout the lengthy course of the litigation. For many years Overton Park was the most-cited United States Supreme Court decision, primarily because of its significance for Federal administrative law. The case remains one of the seminal environmental law decisions.

Other sessions of the program will also reflect on the special focus of this Workshop. There will be an evening event at one of the monuments to transportation, the Space Needle, which was the focus of the 1962 Seattle World's Fair.

**Subjects That Should Be Addressed In Your Agency's Code of Conduct.** Many public sector entities are required by law, regulation or policy to adopt and enforce a Code Of Conduct or Code Of Ethics.
