





# **Data Use Agreement**

## **Monitoring Site**

- Agency access only
- View all data in real-time
- Pure browser-based
- Access to data archive

### <u>Use Terms</u>

- Codified in Data Use Agreement (DUA)
- Full use rights for agencies
- All members see all coverage
- No redistribution to 3<sup>rd</sup> parties
