GOAL #3: Reduce injuries and fatalities caused by alcohol-related motor crashes by 5%


GOAL #4: To bring awareness to the general public No Texting and Driving Campaigns that has been statistically proven to be on the rise across the Nation.

Crash Data

- The purpose of Crash Data Statistics is viable of the inclusion of Highway Safety. Using Crash Data information to obtain high DUI's, speeding, etc., allows better monitoring to identify locations of check points, which includes Law Enforcement participation.
- Using information from Crash Data for location of high crashes, to promote education to drivers with seat belt usage.

Cellphone USE causes head-on collision

GALLUP — A Crownpoint man received injuries to his arm in a head-on collision May 21 that McKinley County Sheriff's deputies say was caused by inattentive driving. the Gallup Indian Medical Center after the accident, which occurred at the intersection of New Mexico highways 118 and 566 about 1 p.m.

Hildreth was traveling west on N.M. Highway 118 while another vehicle, driven by Rydell K. Yazzie, 21, of Crownpoint, was traveling east on the road.

Yazzie said that as he got to the intersection with N.M. Highway 566, when his cellphone rang he began crossing in front of the westbound traffic. He went to answer it as he made his turn into oncoming traffic.

Hildreth said he saw the other vehicle and tried to stop but was unable to. As a result, Yazzie's vehicle struck Hildreth's car head-on.

Yazzie admitted to McKinley County deputies that the accident was his fault. Yazzie was cited for having no driver's license and careless driving. Gallup Independent: Cellphone use causes head-on collision



LEGISLATION – CHANGING LAWS





In 1988, the Navajo Nation passed a primary enforcement law, for seat belt and child restraint use. In 2002, a study found a 50% reduction in motor vehicle injury hospitalization rates for children and youth in the Navajo Nation; comparing before the law, to after.



STATE of NEW MEXICO Status of Strategic Highway Safety Plan

NM has finalized the NM Comprehensive Transportation Safety Plan (CTSP). 12 Emphasis Area's were identified for inclusion in the NM's CTSP to address the safety problems and issues identified to reduce transportation related fatalities and injuries throughout the State. Emphasis areas and subsequent strategies were developed with consideration of addressing the 4 E's of transportation safety (engineering, enforcement, education, and emergency response).

The 12 Emphasis areas are as follows:

- Aggressive Driving and Speeding Crashes Involving Alcohol Impaired Driving • Emergency Medical Services Response • Crashes Involving Fatigued and Distracted Drivers • Intersection Crashes
- Crashes Involving Lane Departures Native Americans Occupant Protection • Pedestrian Crashes • Public Education and Media • Traffic Records • Young Driver Crashes


□ Establishes common goals and priorities

□ Incorporates both behavioral and infrastructure strategies and countermeasures to more effectively reduce highway fatalities and serious injuries


Education gives information about making good choices, such as not texting and driving, avoid alcohol, wearing a seatbelt, etc.

Enforcement of traffic laws and a visible police presence tend to deter motorists from unsafe driving behavior.

Engineering addresses roadway infrastructure improvements to prevent crashes or reduce the severity of collision when they occur.

Emergency Responses provide rapid response and quality of care when responding to collisions causing injury by stabilizing victims and transporting them to other facilities.
