SHRP II Safety Symposium Details “An Exciting Experiment”



Dr. Forrest Council, Chairman of the SHRP II Safety Technical Coordinating Committee, describes the research approach for the Safety focus area as “an exciting experiment.”

The SHRP II Safety Symposium, held August 16-17 at the National Academies’ Keck Center in Washington, DC, drew about 50 members of the safety data community who came to learn about and discuss the new type of research planned for the Safety focus area of SHRP II. Research projects will study driving behavior and crash risks from inside vehicles and from roadways and intersections. Presentations from the [symposium](#) are available on the SHRP II Web site.

Tapping the Talents of a Policy Fellow

Charles Fay, who was awarded a fellowship in the National Academies' Christine Mirzayan Science and Technology Policy Graduate Fellowship Program, is working with the SHRP II Safety focus area during the 10-week program. Charles received his M.S. from Rensselaer Polytechnic Institute's Lighting Research Center, where his focus was photobiology. He has managed research on next-generation lighting technologies and conducted research on human factors related to lighting research.

During his Fellowship at TRB, Charles is primarily involved with investigating legal and privacy issues of human subject testing, international safety research programs, and other safety related topics.
