





About the Naples Airport and its FBO - Naples Aviation

- → Airport authority w/ a 99-year lease for the airport
- → Mission focused five (5) member board of commissioners
- → Inherited the FBO in the 1970's following tenant-landlord dispute
- → Naples ranked #1 place to live for 2024-2025









Post-COVID Trends at Naples Aviation

- → 2nd home market w/ an increasing year round population
- → Most new private flyers have remained despite ~ 30% higher cost
- → Hiring and attrition have stabilized, but cost of living a significant issue
- → Cost of construction up ~ 35%
- → Increasing aircraft foot utilization and footprint, straining FBO resources









Environmental challenges and opportunities

- → Striving to reduce noise impacts Part 150 Study and flight procedure design
- → Aggressively promoting UL 94
- → Pursuing ACI-NA Carbon Accreditation and fleet electrification
- → Conducted 'black soot' (i.e. mold), soil, water and air sampling for lead
- → First airport in FL to transition ARFF vehicles to F3









Is Running the FBO Right for Your Airport?

- → Will it help you become more financially self-sufficient?
- → Can you run it safely, efficiently and like a business?
- → Are you prepared for the investment and unexpected expenses?

FBOs are quite different!

Seen one airport, seen one airport AND Seen one FBO, seen one FBO!

→ Regional customs / differences (example: capital facilities, lease arrangements, etc.)

2023 ACRP Synthesis 129: Landscape of the FBO Industry in 2022

- → Key Themes, continued
 - Pandemic impacts varied significantly
 - Activity was generally booming
 - Since 2018, a slight reduction in airports with fuel
 - Since 2018, largest FBO chains merged / expanded
 - Seasonal markets a new FBO growth area
 - Publicly-owned FBOs remain diverse

Investigator / Panelist Takeaway: data gathering is difficult!

Data is typically private (antitrust laws may also apply)



TREE TRANSPORTATION RESEARCH BOARD



Clear (but sometimes forgotten)!

The FBO and the airport are in a SYMBIOTIC

(and hopefully mutually-beneficial) relationship



Questions from a "typical" AIRPORT viewpoint

- → How is "our" FBO doing relative to others?
 - Do we have the "best" FBO possible?
 - Is our FBO offering the "right" sorts of services?
- → What are the indicators that our airport has enough activity to support multiple FBOs?
- → What are the indicators that we should "give up" on our current FBO / attracting a (better) private FBO and declare a proprietary exclusive?
 - If we're going to (reluctantly) enter the FBO business, what should we know?





Questions from a "typical" FBO viewpoint

- → Airports and FBOs must work together to be attractive to based aircraft / transient traffic
- → Communities must position themselves as business-friendly/ visitor-friendly and air travel friendly ... FBOs depend on this!
- → Airport operators must understand (and work hand-in-hand) to protect the revenue sources that allow an FBO to stay profitable. A well-performing business is key to being able to continue to be a good employer, be a good corporate citizen, make investments in operational improvements and on-airport facilities.

Airport & Community Policies

- → What sorts of business-friendly policies are being implemented by airports and communities to attract / maintain FBOs?
- → What **quantitative metrics** might indicate what FBO business models might be successful at an airport?
- → Qualitative metrics / case studies that describe successful FBO models



Other Possibilities

- → FBO Labor market: recruiting, retention, training policies
- → Drilling down into service lines / SASOs
 - Trends in maintenance shops (new / ceased operations)
 - Trends in flight schools (new / ceased operations)
- → Modeling hangar costs / price sensitivity
- → A comparison of aspects of the US vs European models
- → How are FBOs and airports preparing for AAM / future changes?
- → How are FBOs and airports handling community engagement in climate-focused initiatives?


