



Evolution of CEQ NEPA Regulations40 CFR 1500-1508

- CEQ Final Rule (November 1978)
- EO 13807 (August 2017) One Federal Decision
- CEQ Final Rule (July 2020)
- EO 13807 revoked (January 2021)
- CEQ Phase 1 Final Rule (April 2022)
- Amendments to NEPA in Fiscal Responsibility Act (June 3, 2023)
- CEQ Phase 2 Notice of Proposed Rulemaking (July 31, 2023)
- CEQ Phase 2 Final Rule (May 1, 2024) effective July 1, 2024



Changes

- Time Limits
 - 1 year EAs; 2 years EISs
- Page Limits
 - o 75 pages EAs
 - 150 pages EISs (300 if "extraordinary complexity")
- Page defined as 500 words (excludes citations, appendices, tables, figures, maps)
- Emphasis on: communities with EJ concerns, public involvement, climate change
- Significance context and intensity is back
- Mitigation enforceable; monitoring & compliance plan



Definitions



- Environmental Justice "the just treatment and meaningful involvement of all people, regardless of income, race, color, national origin, Tribal affiliation, or disability, in agency decision making and other Federal activities that affect human health and environment so that..."
- Communities with environmental justice concerns
 means those communities that may not experience
 environmental justice as defined above. To assist in
 identifying communities with EJ concerns... use available
 screening tools (Climate and Economic Justice Screening
 Tool & EJScreen) as appropriate...
- Effects and Extraordinary circumstances definitions include EJ effects

Court Cases

- Seven County supreme court case
 - o 88-mile RR
 - challenged on lack of analysis of downstream impacts of refining/use of crude oil transported by the RR
- Chevron Ruling reversal of deference
- Challenges to the CEQ Phase II regulations





Challenges

- Meaningful public engagement
- Analysis of communities w/EJ concerns, and climate effects/GHG
- Emphasis on cumulative effects/past harms (context)
- New species listings
- Regulatory "Ping Pong"
 - Wetland definition changes
 - CEQ Regs (OFD, CEQ 2020, IIJA, P1-2022, FRA, P2-2024)
- Court cases
- Staffing & industry knowledge base
- One doc for all federal agency actions
- Page limits
- Reviews/review time
- Budget constraints
- Meeting Time Limits more to do in less time!
- Potential for legal action



Potential Solutions

- Do more Pre-NEPA
- Strong knowledgeable PM
- Plan the work/work the plan
- NEPA is like a chess match think 5 moves ahead!
- Know how the parts fit together and the timeframes on the various processes
- Build teams, build trust, build relationships
- Ask questions/share knowledge/work together
- Value added comments only live editing sessions
- Communicate, communicate!

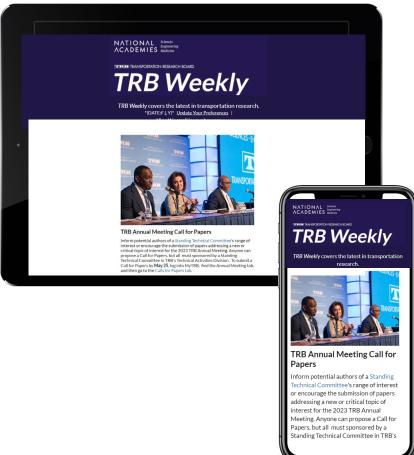


