## AIRPORT COOPERATIVE RESEARCH PROGRAM

Airports are vital national resources. They serve a key role in transportation of people and goods and in regional, national, and international commerce. They are where the nation's aviation system connects with other modes of transportation and where federal responsibility for managing and regulating air traffic operations intersects with the role of state and local governments that own and operate most airports. Research is necessary to solve common operating problems, to adapt appropriate new technologies from other industries, and to introduce innovations into the airport industry. The Airport Cooperative Research program (ACRP) serves as one of the principal means by which the airport industry can develop innovative near-term solutions to meet demands placed on it.

The need for ACRP was identified in *TRB Special Report 272: Airport Research Needs: Cooperative Solutions* in 2003, based on a study sponsored by the Federal Aviation Administration (FAA). ACRP carries out applied research on problems that are shared by airport operating agencies and not being adequately addressed by existing federal research programs. ACRP is modeled after the successful National Cooperative Highway Research Program (NCHRP) and Transit Cooperative Research Program (TCRP). ACRP undertakes research and other technical activities in various airport subject areas, including design, construction, legal, maintenance, operations, safety, policy, planning, human resources, and administration. ACRP provides a forum where airport operators can cooperatively address common operational problems.

ACRP was authorized in December 2003 as part of the Vision 100—Century of Aviation Reauthorization Act. The primary participants in the ACRP are (1) an independent governing board, the ACRP Oversight Committee (AOC), appointed by the Secretary of the U.S. Department of Transportation with representation from airport operating agencies, other stakeholders, and relevant industry organizations such as the Airports Council International-North America (ACI-NA), the American Association of Airport Executives (AAAE), the National Association of State Aviation Officials (NASAO), Airlines for America (A4A), and the Airport Consultants Council (ACC) as vital links to the airport community; (2) TRB as program manager and secretariat for the governing board; and (3) the FAA as program sponsor. In October 2005, the FAA executed a contract with the National Academy of Sciences formally initiating the program.

ACRP benefits from the cooperation and participation of airport professionals, air carriers, shippers, state and local government officials, equipment and service suppliers, other airport users, and research organizations. Each of these participants has different interests and responsibilities, and each is an integral part of this cooperative research effort.

Research problem statements for ACRP are solicited periodically but may be submitted to TRB by anyone at any time. It is the responsibility of the AOC to formulate the research program by identifying the highest priority projects and defining funding levels and expected products.

Once selected, each ACRP project is assigned to an expert panel appointed by TRB. Panels include experienced practitioners and research specialists; heavy emphasis is placed on including airport professionals, the intended users of the research products. The panels prepare project statements (requests for proposals), select contractors, and provide technical guidance and counsel throughout the life of the project. The process for developing research problem statements and selecting research agencies has been used by TRB in managing cooperative research programs since 1962. As in other TRB activities, ACRP project panels serve voluntarily without compensation.

Primary emphasis is placed on disseminating ACRP results to the intended users of the research: airport operating agencies, service providers, and academic institutions. ACRP produces a series of research reports for use by airport operators, local agencies, the FAA, and other interested parties; industry associations may arrange for workshops, training aids, field visits, webinars, and other activities to ensure that results are implemented by airport industry practitioners.

# Letter from the ACRP Oversight Committee Chair



ACRP's extensive library of tools and resources starts with research. Every year the ACRP Oversight Committee (AOC) reviews problem statements submitted by industry professionals and selects projects for funding. The 19 Fiscal Year 2024 projects we selected came from the biggest pool of problem statements we've received in more than five years.

The valuable contributions and active participation of our volunteers and contractors have helped keep ACRP at the forefront of providing actionable, evidence-based resources on emerging issues. This year, the industry wrestled with complex topics such as integrating unleaded aviation gasoline (AvGas), transitioning to a new fluorine-free foam (F3), planning for electric vertical take-off and landing aircrafts (eVTOLS) and other electric vehicles, resiliency, advanced air mobility (AAM),

and workforce development. To facilitate discussion on several of these topics, ACRP organized two successful Insight Events held in 2023 with another three approved by the AOC for 2024. ACRP also participated in events alongside the Airport Minority Advisory Council (AMAC) and the Airport Consultants Council (ACC), embracing the overlap between our missions to provide more opportunities to disadvantaged business enterprises (DBEs) and other underrepresented groups.

Encouraging new voices and building the workforce pipeline is important to the long-term success of our industry. To help achieve this goal, ACRP participated in a young professionals meet-up event, hosted by HOK, Faith Group, and the ACC. We were able to introduce these young professionals to ACRP, highlight ACRP's free resources, and invite the attendees to get engaged early and often. Several AOC members had the opportunity to share their own stories about how they entered the industry and why they love it. We are also in the process of reimagining our Champions program for young professionals to help guide them in their careers.

As we considered how ACRP can best meet the needs of established and new practitioners, we kicked off our next strategic planning effort by participating in the Transportation Research Board's (TRB's) National Aviation System Planning Symposium. At the symposium, industry experts shared their insights about critical issues facing the airport industry and how ACRP can evolve its support to meet those needs. ACRP also finalized a new dissemination plan, which emphasizes outreach to those not yet aware of ACRP and strategies to strengthen the ACRP community.

One constant in the airport industry is that there will always be new challenges, but with proactive planning, innovative thinking, and the continued engagement of our industry professionals, ACRP is confident that together we can lead the way to identify practical, implementable solutions.

As we look toward the future, we are thankful to the Federal Aviation Administration (FAA) for their continued sponsorship and we appreciate their longstanding support.

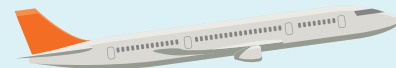

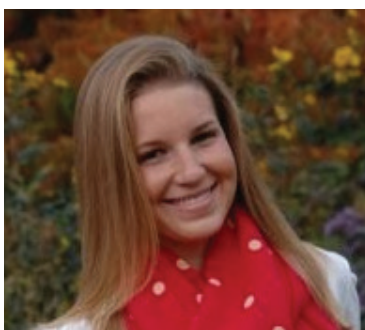
**Jordan Christensen**

Program Coordinator

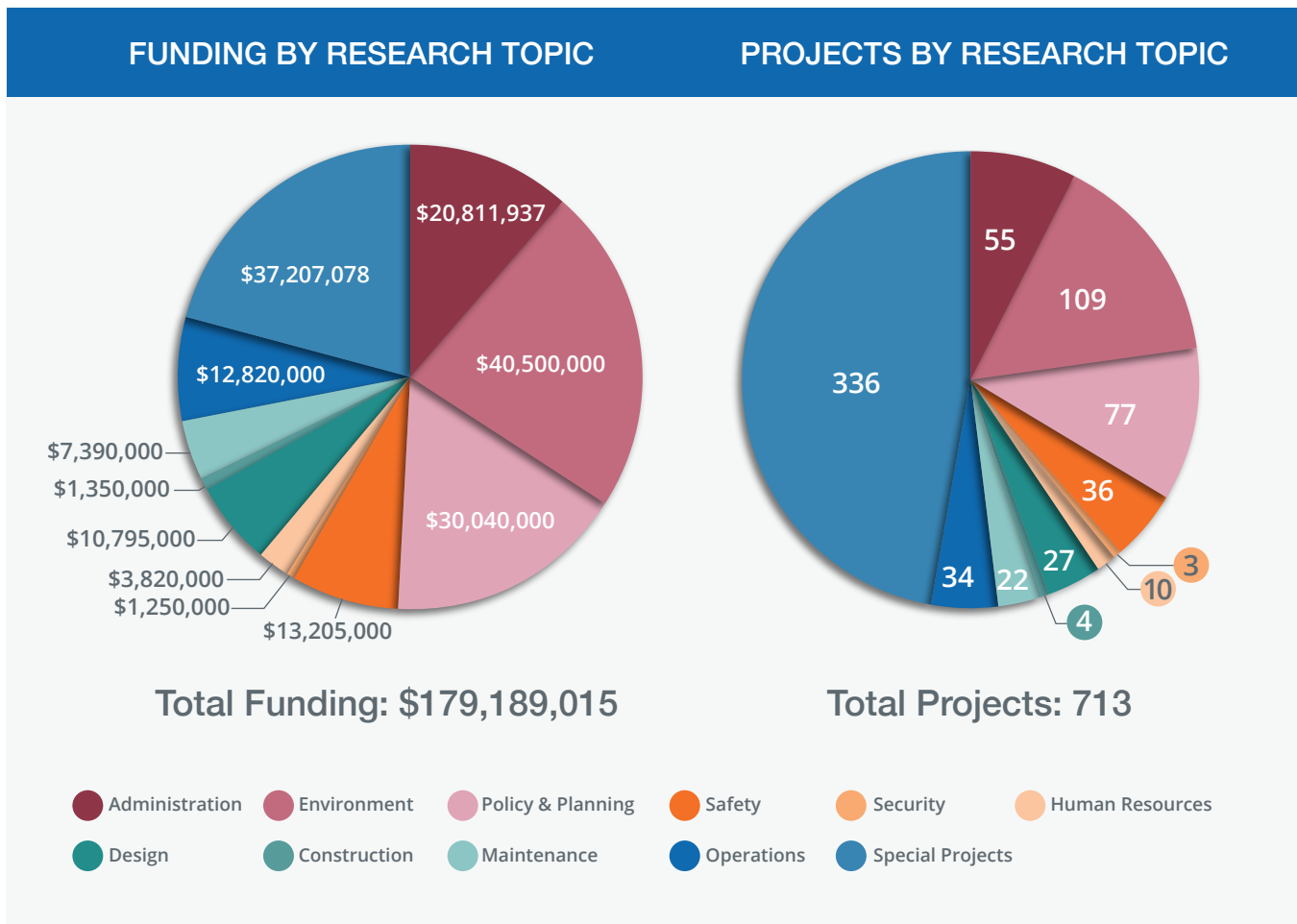

ACRP’s research cycle is driven by industry need and provides a critical opportunity for diverse stakeholders to shape the tools and resources the program produces. Through its annual problem statement process, ACRP solicits research ideas from airport operators, industry associations, federal and state transportation agencies, universities, aviation consultants, and others to understand what issues the industry needs addressed. The ACRP Oversight Committee (AOC) conducts a formal review of the submitted topics and identifies the priority issues that will best serve industry needs. Once the AOC has selected the problem statements that will become research projects, ACRP convenes volunteer project panels that provide technical oversight throughout the research project. In 2023, ACRP selected 19 new research projects, nine synthesis of practice topics, and three legal research topics that address alternative energy sources; seismic activity; easing the customer journey for all passengers, especially those with physical, sensory or cognitive challenges; the legalization of marijuana; and others. These research projects will result in actionable guidance, tools, and other resources that will help airport practitioners address pressing issues in the industry.

## Projects and Funding

ACRP has overseen more than \$179 million in funding for 713 research projects since its inception in 2005. These research projects cover various topics relevant to airports, from environment and safety to construction and maintenance. The charts below illustrate the breakdown of funding and projects by research topic.

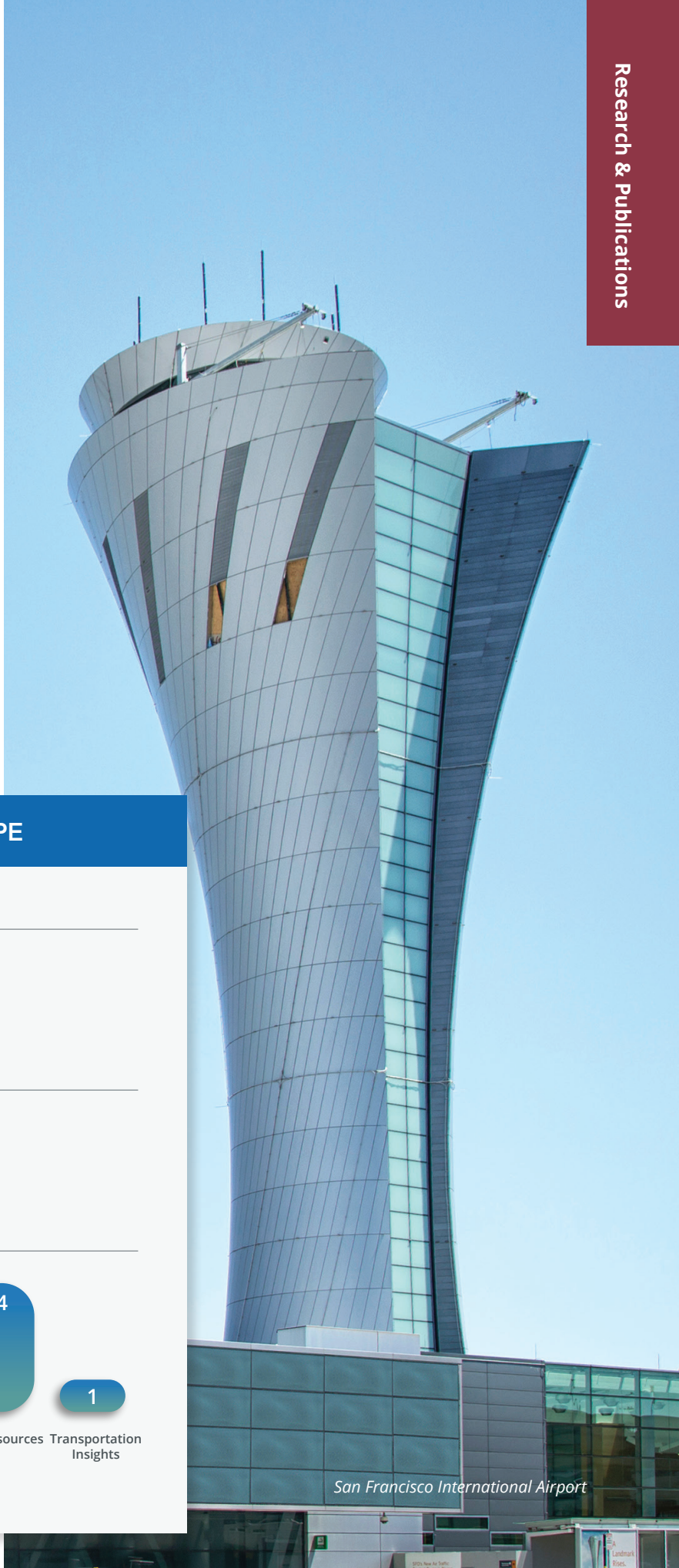




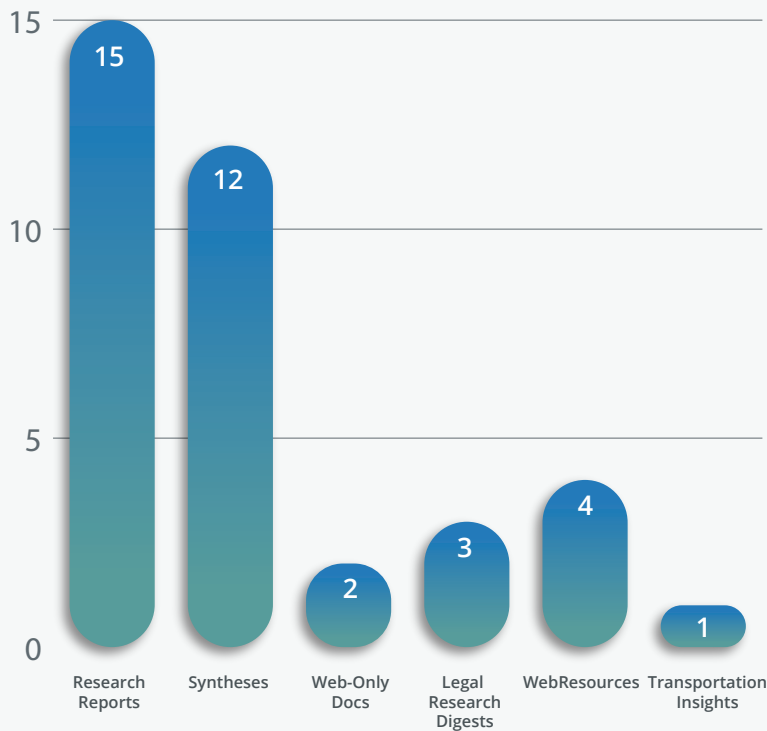
## Research in Action

### 2023 Publication Highlights

ACRP maintains a research library of more than 500 research products that are available online to practitioners around the globe to download for free. In 2023, ACRP published 37 new research products covering a variety of products from managing a flight diversion and emergency response at general aviation airports to applying digital marketing to enhance the customer experience. 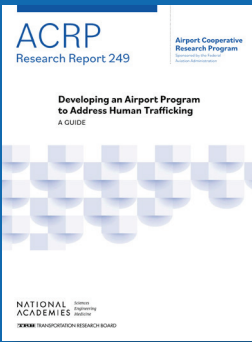


#### 2023 PUBLICATIONS BY TYPE



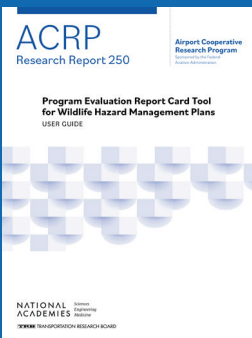

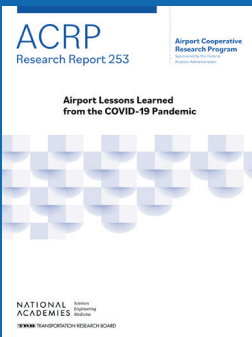
### ***ACRP Research Report 249: Developing an Airport Program to Address Human Trafficking: A Guide***

Human trafficking has emerged as a critical public concern, with tens of millions of global victims who are moved across international borders and between states using various forms of transportation, including buses, trains, and airplanes, among others. Traffickers may be transporting victims through airports, or victims may be traveling of their own accord, unaware that a promised job opportunity at the end of their journey is not legitimate. This guide provides a comprehensive, yet scalable, process to help airports identify and respond to possible human trafficking activity at their facilities.



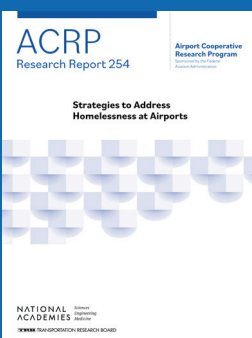
### ***ACRP Research Report 250: Program Evaluation Report Card Tool for Wildlife Hazard Management Plans: User Guide***

The threat of wildlife strikes with aircraft is increasing due to larger bird populations and quieter aircraft. The challenge of managing this risk has prompted the development of Wildlife Hazard Management Plans (WHMPs) by airport operators, which are required to be reviewed regularly. However, there is little information available to assess the effectiveness of these WHMPs over time. This research report is designed to assess the effectiveness of these plans in reducing the risk of wildlife strikes with aircraft over time.



### ***ACRP Research Report 253: Airport Lessons Learned from the COVID-19 Pandemic***

During the COVID-19 pandemic, airports faced challenges such as implementing health protocols, accessing trusted information, accommodating social distancing, and using effective technologies to control the spread of the virus. This research report is intended as a resource for continued response to COVID-19 and future communicable disease outbreaks. The report summarizes 124 interviews with representatives from 127 airports of all sizes and regions.

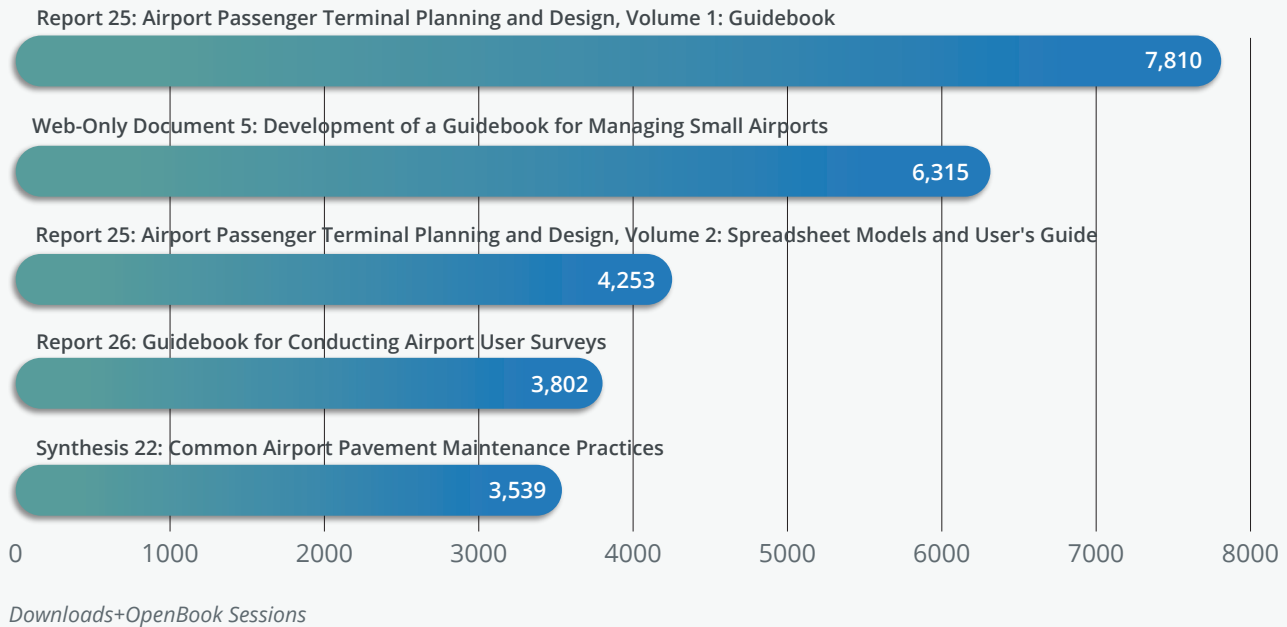


### ***ACRP Research Report 254: Strategies to Address Homelessness at Airports***

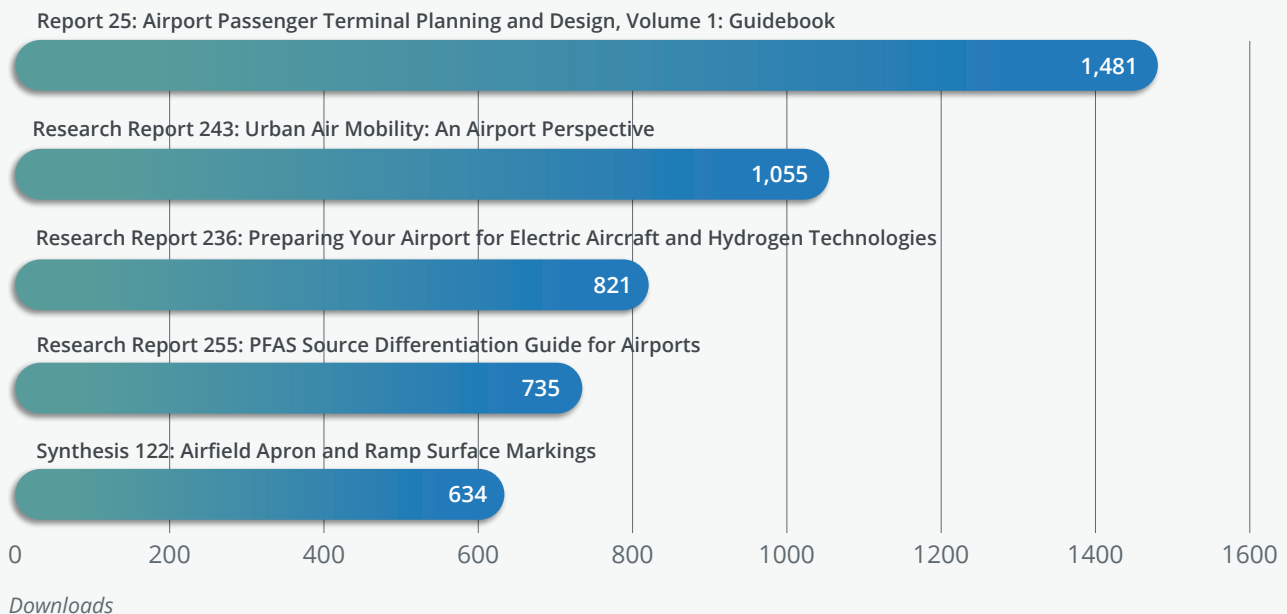
The purpose of this guide is to help airport operators understand and respond to people experiencing homelessness on airport property (i.e., at their built facilities and on surrounding airport-owned land). The guide provides airport operators with the fundamental knowledge needed to understand homelessness and its intersection with airports, an understanding of the contextual factors that influence the prevalence of homelessness in airport contexts, and detailed actions that airport practitioners can consider developing and implementing to support a program to address homelessness.

ACRP publications were downloaded or viewed online more than 192,000 times in 2023. The graphs below show the publications with the most engagement (including being viewed or read online without being downloaded) and the publications that were downloaded the most in 2023.

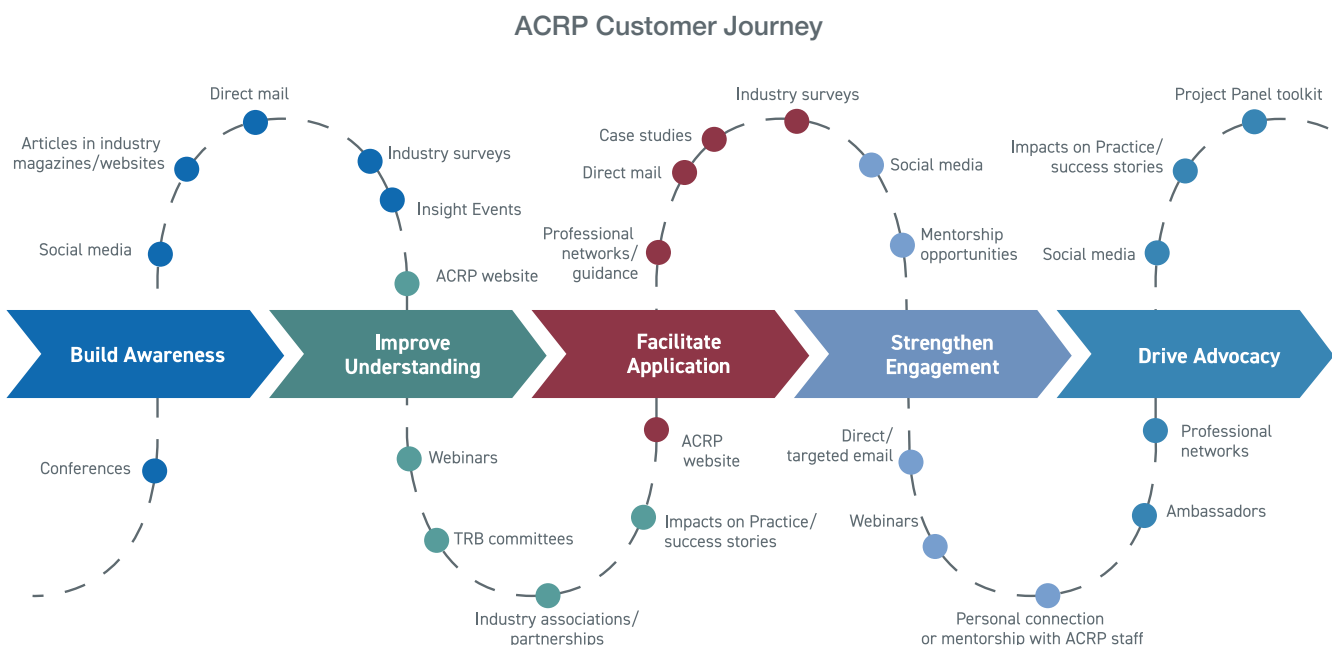
## 2023 Dissemination Plan

2023 saw the development of a new dissemination plan by ACRP. As stated in Goal 3 of ACRP’s Blueprint for the Future: Strategic Plan 2020–2024, improving dissemination and encouraging utilization of ACRP products continues to be a priority of the program. Guided by the objectives detailed in the 2020–2024 Strategic Plan and building on ACRP’s existing dissemination efforts, the 2023 Dissemination Plan establishes an actionable roadmap that:

- Identifies target audiences and their barriers and motivations to engaging with ACRP.
- Defines metrics to track progress across dissemination programs.
- Outlines recommendations to enhance dissemination activities and extend ACRP’s reach.
- Supports ACRP’s goal of delivering high-quality research products to practitioners across the aviation industry.

The activities outlined in the plan are guided by three pillars of dissemination—building awareness of ACRP, increasing access to ACRP resources, and strengthening engagement with practitioners. The activities supporting each pillar work together to enhance ACRP’s efforts to reach a diverse array of practitioners with practical research products, particularly those not yet aware of ACRP.

Leveraging a mix of dissemination tools, the plan aims to increase the number of individuals who have some awareness and understanding of ACRP and then guide them toward more engagement in which they use ACRP resources and are empowered to share ACRP’s message with their peers. ACRP considers airport practitioners to be its audience—that is, its customers—and has captured this journey in the five stages shown below. The supporting dissemination tools are shown as points woven through the customer journey and illustrate some of the ways an individual can receive information about and connect with ACRP.



## TRB’s National Aviation System Planning Symposium

ACRP’s Strategic Plan Blueprint for the Future 2020–2024 will be reviewed by former and current members of the AOC in January 2024 to assess the goals and identify action items. Because industry feedback has always been an important consideration in AOC decisions, members of the TRB aviation committees and other participants at the National Aviation System Planning Symposium in May of 2023 began the review of the strategic plan by providing constructive feedback on what ACRP is doing well, could be doing better, and which activities should and should not be continued. Their insights will be the starting point for determining ACRPs roadmap for the next five years.

## Communication and Collaboration

ACRP engages industry practitioners through a variety of programs, competitions, and events. These activities create valuable opportunities for ACRP to interact and build relationships with stakeholders from seasoned industry executives to graduate and undergraduate researchers. In 2023, ACRP continued its outreach through established programs and laid the groundwork for new collaboration opportunities in 2024.

### Problem Statements

ACRP relies on feedback and insight from industry practitioners to help inform the research agenda. ACRP gathers this insight largely through the collection of problem statements, which can be submitted throughout the year using a streamlined online process. Users can submit problem statements regarding issues they encounter in their day-to-day experiences as airport practitioners. In 2023, ACRP received 82 problem statements from the industry, a 30% increase from the five-year average. TRB’s aviation committees also played an important role in the 2023 submission cycle, guiding practitioners in the development of 12 problem statements. Examples of themes that emerged in this year’s submissions included accommodating the cognitive and sensory diversity of travelers, resiliency, and engaging with new technologies.

## Insight Events

ACRP Insight Events bring airport industry leaders, subject-matter experts, and researchers together to discuss emerging topics of significance to airport operators. These in-depth, face-to-face gatherings are designed to promote communication and collaboration, foster innovation, and help identify areas of future interest and research. ACRP hosted two Insight Events in 2023 and has already started planning for three Insight Events to be held in 2024.

## The Future of Airport Finance

ACRP held the Future of Airport Finance event in March 2023. Participants in the event discussed the reality airports face with an uncertain recovery from the global pandemic, new and ongoing costs, and changing stakeholder expectations. The event brought together airport practitioners, industry experts, policymakers, and airport partners for discussion and dialog on the future of airport finance.

## On-Demand Aviation Services for Mobility, Logistics, Emergency Response, and Humanitarian Use Cases

ACRP held the On-Demand Aviation Services event in July 2023. The central theme of the event was a discussion of how modern technology has enabled ideas like advanced air mobility (AAM)—a broad concept in which consumers have on-demand access to air mobility, cargo and package delivery, healthcare applications, and emergency services through an integrated and connected multimodal transportation network. Attendees participated in presentations and breakout sessions that centered around:

- Supporting institutional readiness and capacity building for AAM among airports and public agencies.
- Helping public-sector stakeholders prepare and integrate emerging practices into planning, policy, and operations.
- Identifying research needs that could help inform public policy at all levels of government.

## Collaboration Initiatives

ACRP collaborates with airport stakeholders throughout the research process. This year, ACRP sought opportunities to ensure new voices were invited to provide their distinct perspectives on current challenges within the industry.

In July 2023, ACRP participated in the ACC’s Young Professional Meet Up that was hosted in the Saint Louis, Missouri, area. The event, sponsored by HOK, Faith Group, and the ACC, provided an opportunity for professionals in the early stages of their career to learn about opportunities in the airport industry. Three members of the AOC—Balram “B” Bheodari, General Manager of Hartsfield-Jackson Atlanta International Airport, Rhonda Hamm-Niebruegge, Director of Saint Louis Lambert International Airport and the current AOC Chair, and Cathryn Stephens, Director of Eugene Airport—shared their career stories and participated in a question and answer session. ACRP Manager Marci Greenberger provided an overview of the program and ways to get engaged.

ACRP also joined the Airport Minority Advisory Council’s (AMAC’s) 38th Annual Airport Business Diversity Conference held in San Antonio, Texas. ACRP is working with AMAC to foster greater participation of minorities and women in its program, including enhancing diversity on its project panels and among its research contractors. Marci Greenberger attended the conference on behalf of ACRP, which exhibited there for the first time. It was an excellent venue for meeting new people and educating them about ACRP.

In August 2023, ACRP decided to sunset the Champions program. Initially designed to close a gap in the industry by creating a space for young professionals to come together, this niche has now been filled by industry programs like the American Association of Airport Executives (AAAE) Young Professionals Committee, the ACC Young Professionals Forum, and the Airport Council International–North America (ACI-NA) Young Professionals Steering Committee. As such, ACRP will be focusing on helping all types of new practitioners—including young professionals and new entrants to the industry—connect with resources, community, and opportunities to advance their professional capabilities. ACRP looks forward to launching a variety of initiatives to support new practitioners and welcome them to the airport community.

## Industry Conferences

In 2023, ACRP participated in 10 conferences in nine states, encompassing a diverse audience of industry stakeholders. This year, ACRP debuted its newly designed exhibit booth to help visitors connect with ACRP staff and learn about the many resources available from the program. The new brighter and warmer design was part of an overarching effort to refresh the look and feel of ACRP's branded materials and enhance engagement. The booth includes key messaging to concisely convey ACRP's mission and value to industry stakeholders. ACRP also integrated more digital infrastructure into its display such as monitors displaying past and current projects and tablets to create visual interest and facilitate on-the-spot engagement with research products and other resources.

## University Design Competition

The ACRP University Design Competition provides students with a unique opportunity to learn about and contribute to airport industry research. Through their work with airports and other stakeholders, the program also helps students lay the groundwork for careers as future airport employees and practitioners. This nationwide contest invites undergraduate and graduate students to form teams and—alongside their faculty advisors—devise novel approaches and solutions that address airport issues in four key areas: airport operation and maintenance, runway safety/runway incursions/runway excursions, airport environmental interactions, and airport management and planning. Participants have a chance to win cash prizes for their solutions, and top-ranking teams can showcase their work at a national award ceremony. For the first time, the award ceremony was live streamed to any interested parties and at one point during the event, more than 30 parties were watching!

- Purdue University: *Implementing Airside Bioswales for Stormwater Management at the Airport* – 1st place in Airport Environmental Interactions Challenge.
- The Pennsylvania State University: *RunwAI* – 1st place in Airport Operation and Maintenance Challenge.
- Purdue University: *Active Runway Indication System (ARIS)* – 1st place in Runway Safety/Runway Incursions/Runway Excursions Challenge.
- Purdue University: *Accessible Air Travel Information System (A2TIS)* – 1st place in Airport Management and Planning Challenge.

## Graduate Research Awards

The ACRP Graduate Research Awards promote critical thinking, interdisciplinary discussions, and research among future aviation managers, operators, designers, and policymakers. Geared toward graduate students, this program encourages applied research on airport and aviation system matters with the goal of enhancing the quality, reliability, safety, and security of civil aviation. In 2023, 11 students were granted ACRP funding to pursue their proposed research projects. Alongside financial support, awardees gain access to a panel of expert advisors in their research field, an opportunity to present their final papers at the TRB Annual Meeting, and the chance to have their papers considered for publication in the *Transportation Research Record: Journal of the Transportation Research Board*.

# Digital Engagement

## Social Media

As a result of these efforts, ACRP has seen a combined 240% growth in Facebook and LinkedIn followers

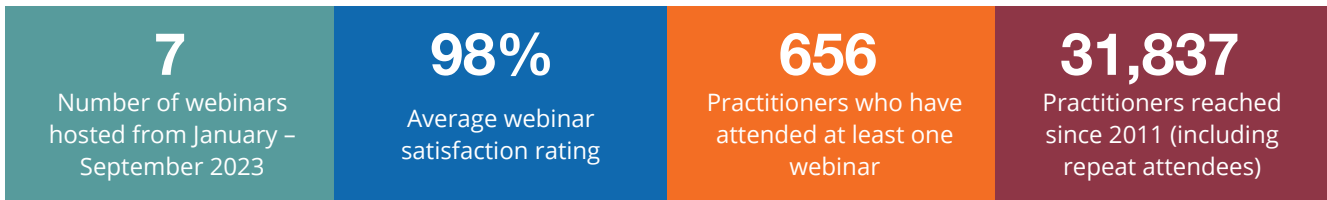

## Webinars

TRB’s ACRP free-to-attend webinar series offers research teams and principal investigators (PIs) the opportunity to discuss their research findings, lessons learned, and cutting-edge solutions to issues facing the airport industry with a large audience of airport practitioners across the country and globally. These informational and interactive webinars allow attendees to engage with ACRP research by hearing firsthand accounts of the research process and having the opportunity to ask questions to the research teams.

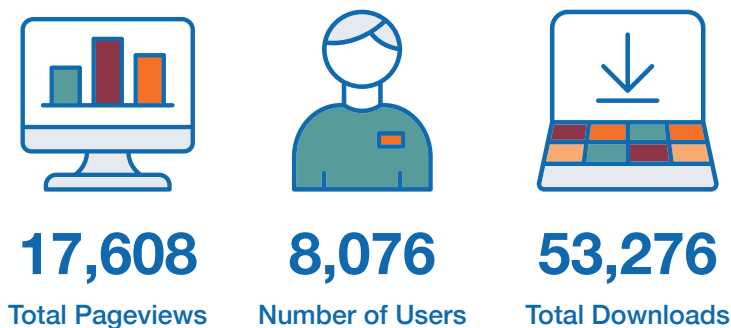


**Most Attended Webinar of 2023 – Electrification and Hydrogen Technologies in Airports:** Airports of all sizes want to understand the broader industry shift toward alternative power solutions and how to prepare. TRB hosted a webinar on May 25, 2023, based on *ACRP Research Report 236: Preparing Your Airport for Electric Aircraft and Hydrogen Technologies* that introduced the emerging electric and hybrid electric aircraft industry. Presenters estimated potential market growth, provided guidance to help airports estimate the potential impact on their facilities, and suggested ways to prepare for this industry shift. Attendees were able to preview the corresponding toolkit, which includes a database of electric aircraft and estimations of electric power requirements. Presenters also discussed the broader industry landscape of alternative power in aviation.

**Of the 163 webinar attendees:**

- 100% felt the presenters helped them to understand the content.
- 93% have plans to use the content featured as a reference for their own work or as information to share with colleagues.
- 28% were first-time attendees of a TRB ACRP webinar.

## ACRP Website



Data runs through September 30, 2023

The ACRP website is a central hub for practitioners and other industry stakeholders to access resources, tools, and opportunities for engagement such as Insight Events and problem statement submissions. In 2023, ACRP kicked off a refresh of its website design to ensure visitors can efficiently find the content that is most relevant to them. ACRP also explored ways to enhance and maintain search engine optimization to position ACRP as a high-ranking site in external search engine results.
